

RESOLUTION NO.2009-65

A RESOLUTION REQUESTING THE NEVADA COUNTY BOARD OF SUPERVISORS  
TO AUTHORIZE THE COUNTY AUDITOR AND THE COUNTY TAX COLLECTOR  
TO LEVY AND COLLECT DELINQUENT SEWER SERVICE CHARGES  
AGAINST CERTAIN PROPERTIES WITHIN THE CITY OF GRASS VALLEY  
AND THE UNINCORPORATED TERRITORY OF NEVADA COUNTY

WHEREAS, the City of Grass Valley has submitted bills to certain property owners for sewer charges assessed in accordance with Grass Valley Municipal Code Chapter 13.12; and

WHEREAS, the recipients of SEWER services applicable to those charges have not made payment; and

WHEREAS, the California Health and Safety Code Section 5473 authorizes a City to place delinquent sewer charges on the tax roll after the approval by a two-thirds vote by the members of the legislative body;

NOW, THEREFORE, BE IT RESOLVED by the Council of the City of Grass Valley, as follows:

1. That the Nevada County Board of Supervisors is hereby requested to authorize the Nevada County Tax Collector to levy and collect unpaid sewer charges in the amount and against the Parcel and Owners of Record as set forth on Exhibit "A" attached hereto and incorporated herein by this reference.

2. Exhibit "A" represents charges that are 50 days delinquent as of June 5, 2009, and does not reflect payments received after that date. Exhibit "A" is subject to deletion for owners rendering payment prior to submitting to the County.

3. That the City Council understands that costs for this service will be charged in accordance with the "Standard Form Tax Collection Services" contract between the City of Grass Valley and the County of Nevada.
