

RESOLUTION NO. 2010-06

**A RESOLUTION OF THE CITY COUNCIL OF GRASS VALLEY
AMENDING GARBAGE SERVICE COLLECTION FEES, CHARGES
AND RATES SCHEDULE PURSUANT TO GRASS VALLEY MUNICIPAL
CODE SECTION 8.24.150.**

WHEREAS, Grass Valley Municipal Code Section 8.24.150 provides that garbage service collection fees, charges and rates schedule for City shall be established and fixed by resolution, and may be amended from time to time thereafter, upon majority vote of the City Council; and

WHEREAS, the City Council on February 9, 2010, did hold a properly noticed public hearing for the purpose to change and establish a garbage collection fees, charges and rates schedule for City Garbage Collection Services to become effective February 1, 2010; and

WHEREAS, pursuant to the contract between the City and Grass Valley Disposal, Inc. for Garbage Collection Services, as amended on February 13, 1991, and assigned to Waste Management, Inc., which provides for an annual rate adjustment to be based upon the Consumer Price Index for the United States with annual modifications of 75% of the CPI with a minimum of 3% with changes to be effective February 1 of each year; and

WHEREAS, the current Consumer Price Index for the United States (City Average - All Urban Consumers) ending for November 2009 is calculated at 1.38%, which means that Waste Management, Inc. is entitled to the minimum 3 % rate increase.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF GRASS VALLEY, as follows:

1. That the foregoing is true and correct.
2. That the Council finds and determines that said public hearing was held at the time and place fixed for same.
3. That in accordance with Section 8.24.150 of the Grass Valley Municipal Code and pursuant to the agreement with Grass Valley Disposal, Inc., as amended on February 13, 1991, subsequently assigned to Waste Management, Inc., the garbage collection fees, charges and rates schedule be amended by the schedule attached hereto as Attachment A.
4. That said schedules shall be the only basis upon which garbage, rubbish or waste matter, as collected under provisions of compensation for services is hereby adopted to become effective February 1, 2010, respectively, and to continue thereafter until amended otherwise by the Council.
