    RECOMMENDATION: That the Council discuss the previous meeting's applicant interviews and consider making an appointment.

The Mayor opened up public comment on this item and Sue Hudson, Lenoria Court, Grass Valley came forward and spoke in favor of applicant Jeri Glover. Council Member Swarthout seconded. A roll call vote was taken with Council Members Arbuckle, Levine and Swarthout voting yes and Mayor Fouyer voting no. Motion passed 3-1.
