B. REPORT OUT OF CLOSED SESSION

- D. INTRODUCTIONS AND PRESENTATIONS
- 1. Administration of the Oath of Office to Ben Aguilar Kristi Bashor, City Clerk administered the oath of office to Ben Aguilar.
- 2. Police Department Employee and Volunteer of the Year Recognition
  John Foster, Chief of Police presented this item to Joe Repetski, Volunteer of the Year. Roger Wayna the Animal Shelter spoke about Joe and the Mayor presented Joe with a plaque. The Chief then spoke about Clint Lovelady who received the employee of the year award for the Police Department and the Mayor presented him with a plaque and special uniform pin.
- E. PUBLIC COMMENT Jeri Glover, Joyce Drive, Grass Valley came forward and spoke about the St. Piran's Day celebration coming up on Saturday, March 14, 2015. Tim Kiser, Public Works Director/City Engineer came forward and spoke about the upcoming road construction project. He announced there will be a meeting at 9:00 AM at City Hall in the Hullender Room. He said that the construction should take about 20 days. Craig Kuncle and Monte Christie of Geo-Logics and Associates came forward to introduce themselves and their company to Council. Kevin Dredge, came forward and congratulated Ben, Joe and Clint. He then spoke about Terry Lamphier and the laws about child

pornography and that they need to be changed.

Council Member Levine Moved to approve the Consent Agenda as presented. Council Member Arbuckle seconded and the motion carried by a 5-0 roll call vote.

- 3. <u>Approval of Action Minutes of the Regular City Council Meeting of February 24, 2015 RECOMMENDATION:</u> Approve minutes as submitted.
- 4. <u>Approval of Contract (CHP use of GVPD Range)</u>
  <u>RECOMMENDATION:</u> Authorize Chief of Police to sign a range use contract allowing CHP use of the GVPD range based on compensation outlined in the contract
- 5. <u>Approval to accept grant from Networked Insurance Agents/Fireman's Fund RECOMMENDATION:</u> Approve the City Manager and Interim Fire Chief to accept a grant from Networked Insurance Agents/Fireman's Fund, increase revenue and expense accounts to reflect grant funds received.
- 6. Proposal to Contract with Grass Valley Little League to maintain and operate the Condon Park Baseball Facilities Year Round

  RECOMMENDATION: That Council: 1) consider and approve an agreement with Grass Valley Little League, a non-profit organization, to operate and maintain the Condon Park Baseball Facilities year round; and 2) authorize the Public Works Director/City Engineer to execute the agreement, including renewals and amendments for up to five (5) years, subject to legal review.
- 7. <u>GVTIF Update Approve Professional Service Agreement RECOMMENDATION:</u> That Council: 1) authorize the Public Works Director/City Engineer to execute a professional service agreement with Parsons Brinckerhoff, Inc. for the GVTIF Update in the amount of \$49,086 with the ability to approve amendments for an additional 10% of the contract amount, subject to legal review; and 2) authorize a budget transfer in the amount of \$30,000.00.

acres located at 154 Scandling Avenue from C-2 HFBD (Central Business Hills Flat Business District) to C-3 HFBD.

<u>RECOMMENDATION</u>: After conducting the public hearing: 1) waive the reading of the ordinance in its entirety and read by title only; 2) introduce the ordinance rezoning 3.10 acres; and 3) adopt the proposed negative declaration.

Council Member Arbuckle seconded and the motion carried by a 5-0 roll call vote.
