D. PUBLIC COMMENT

E. CONSENT ITEMS – (roll call vote).

Council Member Swarthout moved to approve the consent agenda with the exception of item 3.2 which she asked to have pulled from the agenda and said that she was recusing herself from items 3.3 and 3.4. The City Attorney stated that Council Member Arbuckle needed to recuse herself from items 3.2 and 3.3 Council Member Levine seconded and the motion carried by a 5-0 roll call vote. Council Member Arbuckle, Swarthout and Mayor Fouyer drew straws to see who would be staying for item 3.2. Mayor Fouyer drew the short straw so Council Members Arbuckle and Swarthout left the Council Chambers. Vice Mayor Levine moved to approve consent item 3.2 Resolution No. 2015 –13 Directing Filing of Annual Report Pursuant to the Landscaping and Lighting Act of 1972 – Assessment District No. 1988-2, Residential Landscaping and Lighting District. Council Member Aguilar seconded and the motion carried by a 3-0-2 roll call vote with Council Members Arbuckle and Swarthout abstaining.

2. <u>Approval of Action Minutes of the Regular City Council Meeting of April 28, 2015</u> RECOMMENDATION: Approve minutes as submitted.

- 3. Adopt four Resolutions directing the filing of annual reports for Landscaping and Lighting Districts (LLD) Annual Assessments for fiscal year 2015/2016 and Benefit Assessment Districts (A.D.) Annual Assessments for fiscal year 2015/2016.

 RECOMMENDATION: Adopt Resolutions numbered 2015-12, 2015-13, 2015-14 and 2015-15 directing the filing of annual reports for Commercial LLD #1988-1, Residential LLD #1988-2, Morgan Ranch Unit 7 A.D. #2003-1 and Morgan Ranch West A.D. #2010-1.  - 5. <u>Appointment of Planning Commissioners</u>
 <u>RECOMMENDATION:</u> That the Council approve the nominees recommended for approval by Mayor Fouyer and Council Member Aguilar.

Council Member Swarthout moved and Council Member Arbuckle seconded to appoint Jacqueline Hawkins and Dawn Bateman to the Planning Commission. The motion carried by a 5-0 roll call vote.

6. <u>Community Funding Requests</u>
<u>RECOMMENDATION:</u> That the City Council consider community group funding request presentations and direct staff on desired funding for the FY-16 budget.

John Gregory CEO of the Economic Resource Council Presented his request for funding for the ERC of \$10,000. Melinda Booth of Wild and Scenic presented their request for \$5,000. Keith and Robin Davies Co-CEO's of the Greater Grass Valley Chamber of Commerce presented the request for funding for the Greater Grass Valley Chamber of Commerce for \$10,000. The Mayor opened this item for public comment. A gentleman from Round Valley Road came forward and stated that he would like to see results from the ERC funding. Barbara Getz, owner of the Del Oro Theater spoke in favor of supporting Wild and Scenic. Roger Hicks, Yuba Docs, spoke in favor of Wild and Scenic. The Mayor closed public comment. Vice Mayor Levine moved to grant the \$10,000 funding request for the ERC. Council Member Arbuckle seconded and the motion carried by a 5-0 roll call vote. Council Member Arbuckle moved to pull the Wild and Scenic item from this agenda and asked that Staff bring this back on a future agenda for further discussion and Council Member Swarthout seconded. The motion carried by a 4-1 voice vote with the Mayor voting no.

7. <u>Grass Valley Downtown Association Funding requests</u>
<u>RECOMMENDATION:</u> That the City Council consider community group presentations and direct staff on desired funding for the FY-16 budget

Council Member Swarthout recused herself from this item. Steve Rosenthal, Treasurer for the Grass Valley Downtown Association presented their request for funding of \$10,500. Council Member Arbuckle moved and Council Member Aguilar seconded to fund the Grass Valley Downtown Associations request for \$10, 500. The motion carried by a 4-0-1 voice vote with Council Member Swarthout abstaining by recusal.

8. <u>Potential Park Improvement Funds</u>
<u>RECOMMENDATION:</u> That Council provide staff direction on the use of Quimby Act funding

Tim Kiser, City Engineer/Public Works Director presented this item to Council. There was discussion on how the funds could be used and it was suggested that perhaps Pickleball courts could be put in at Mautino Park. Judy Tortalia, President of the Grass Valley Pickleball Club spoke in favor of courts being put in at Mautino Park. Victor Simone Ambassador for the USA Pickleball Association also spoke in favor of courts being put in. Council Member Swarthout moved to direct staff to investigate costs Pickleball Courts and the possibility of partnering with the Pickleball Club for Pickleball courts to be put in at Mautino Park and return with a possible plan at a future Council meeting. Council Member Aguilar seconded and the motion carried by a 5-0 voice vote.

Council Member Swarthout attended the ERC Board Meeting and the Friendship Club Graduation. Vice Mayor Levine attended the Pasta judging and SEDcorp meeting and was named chair. Council Member Arbuckle attended Legislative Action Meeting, the League Board of Directors Meeting, Prayer Breakfast and Presentations in Sacramento. Mayor Fouyer attended the Prayer Breakfast. The Mayor requested that the next agenda have an item for recognition of officer Hooper.
