4. <u>Appropriations Limit for Fiscal Year 2015-16</u>
<u>RECOMMENDATION:</u> After considering public comment, adopt Resolution 2015-33 establishing the Appropriations limit for the City of Grass Valley for Fiscal Year 2015-16.

5. Public Hearing to review and consider adopting the General Budget of the City of Grass Valley and the Successor Agency for Fiscal Year 2015-16.
RECOMMENDATION: After considering public testimony, adopt Resolution No. 2015-34 approving the General Budget for the City of Grass Valley for fiscal year 2015-16, which includes a budget for the Grass Valley Redevelopment Successor Agency and the half cent sales tax measure (Measure N). A 4/5s vote is required for adoption of the budget.
