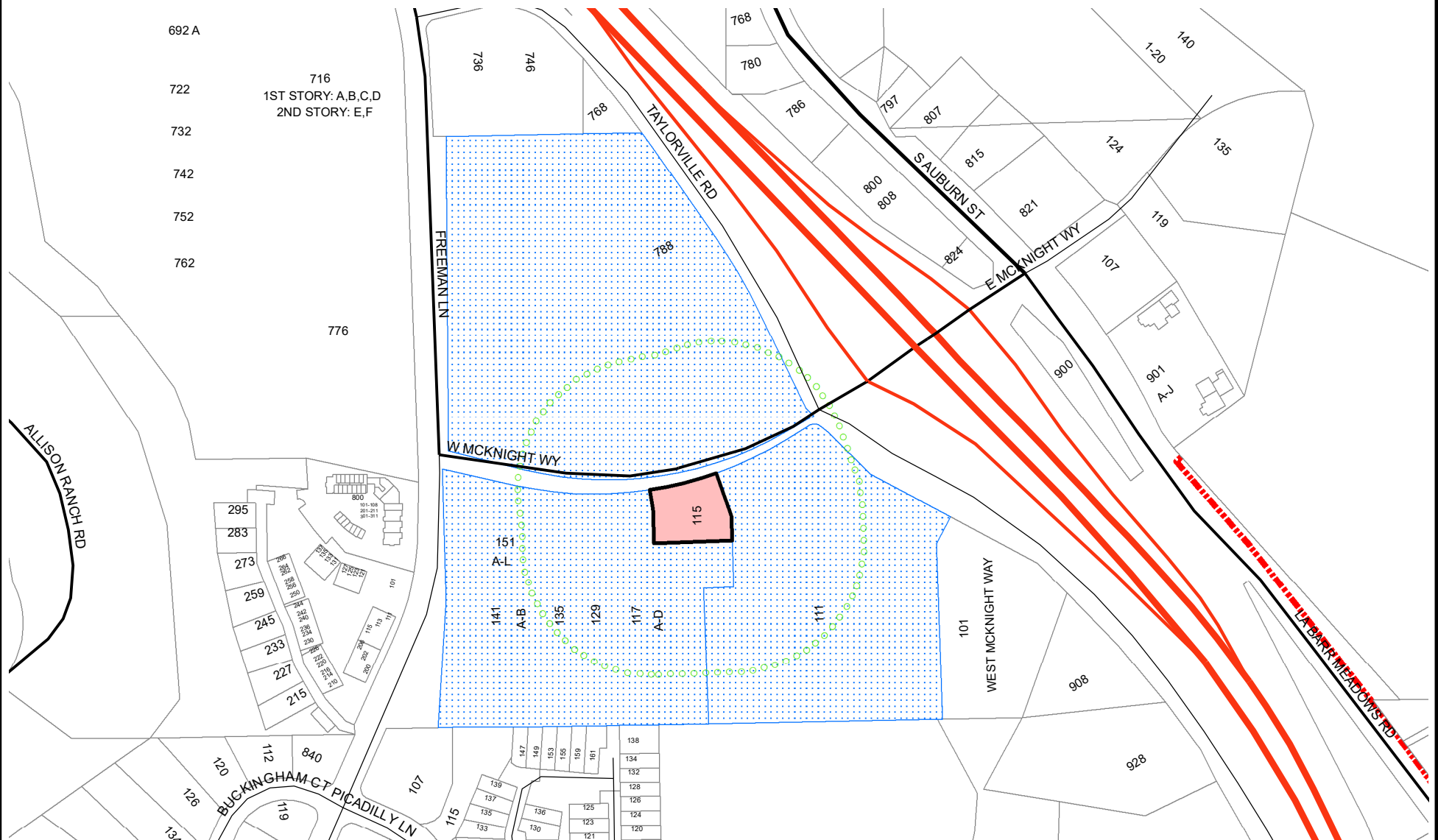

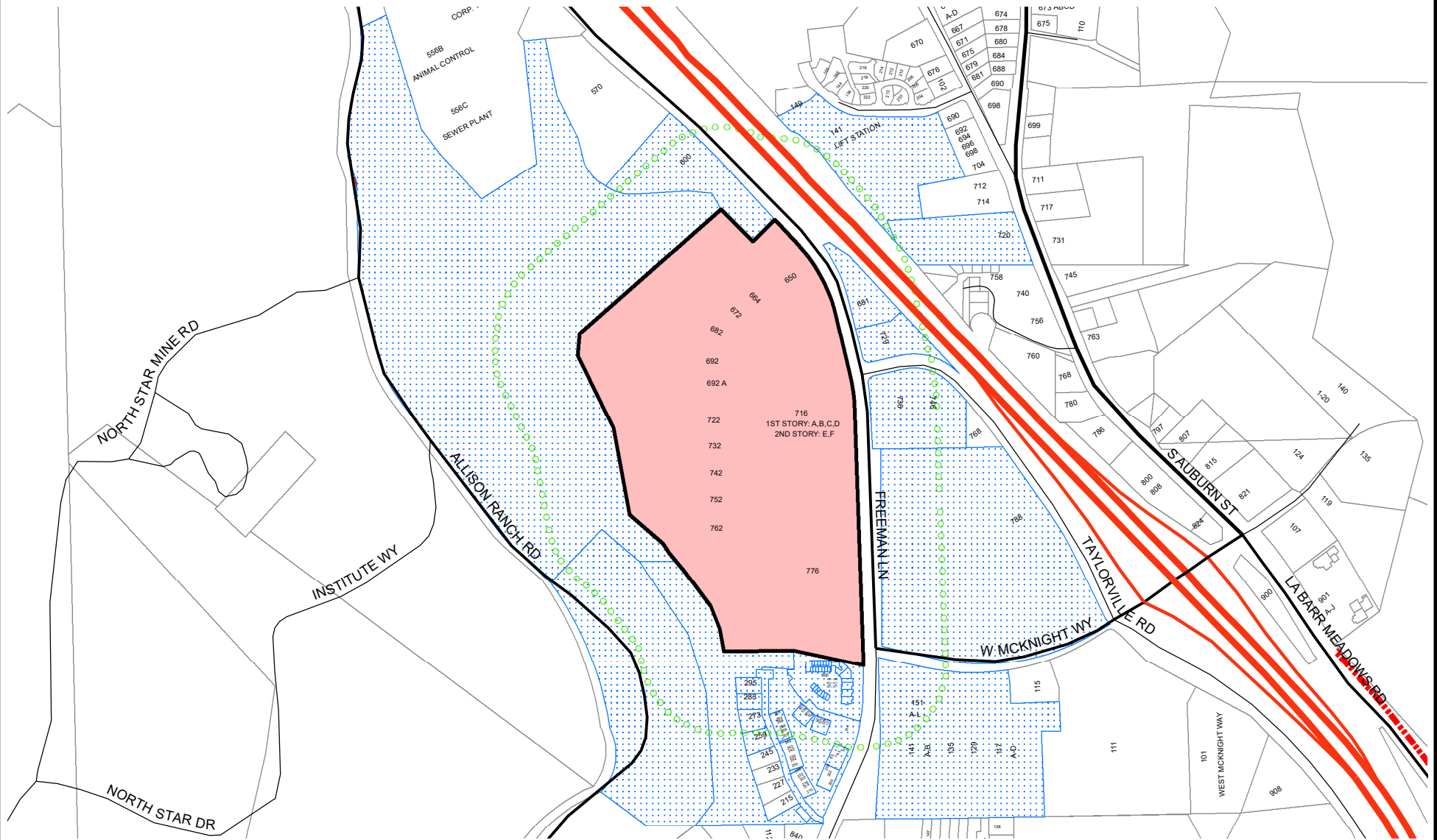
City of Grass Valley Notification Map

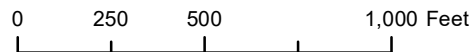

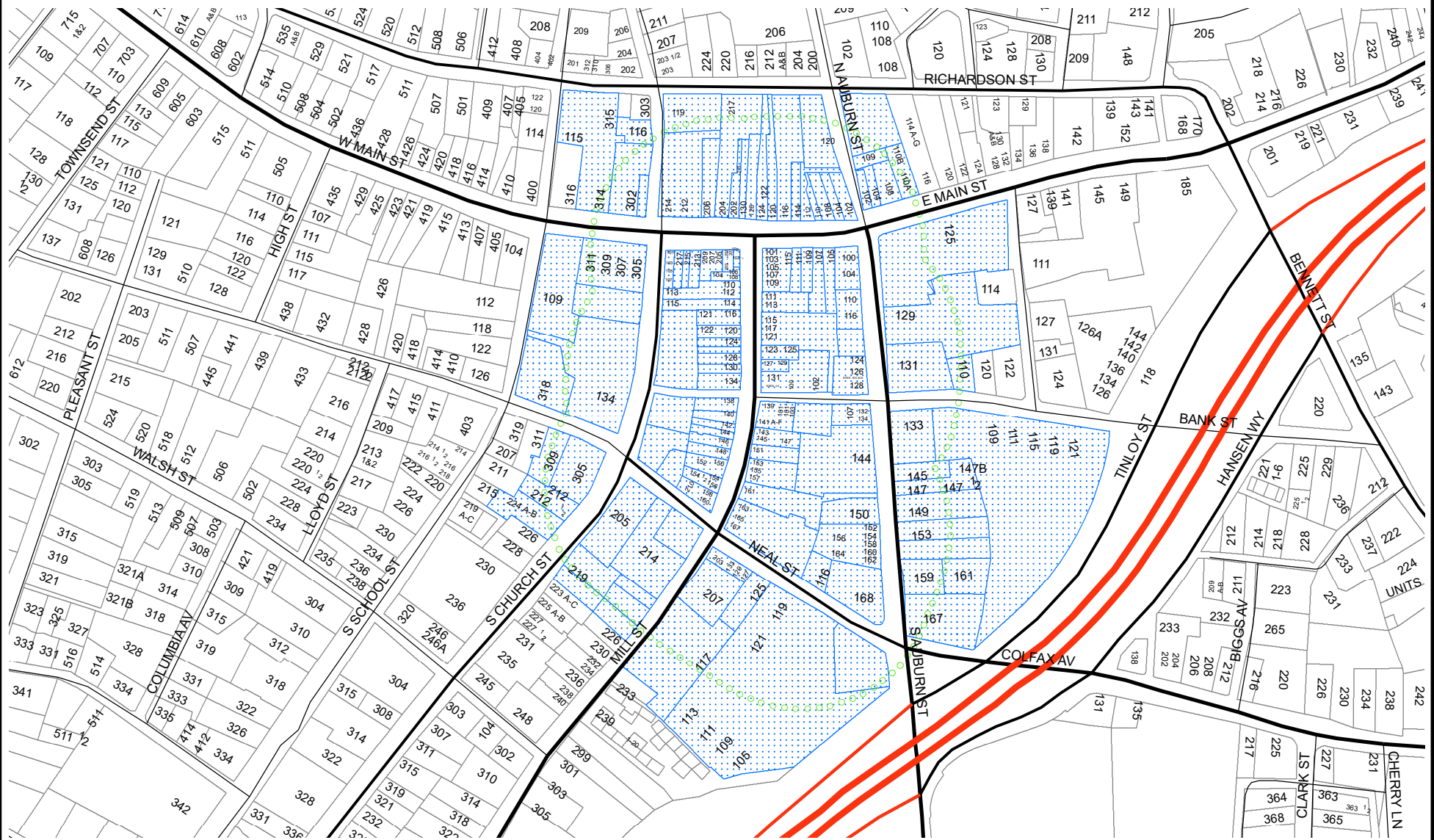

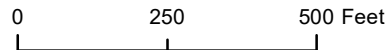
