Minor Use Permit (22PLN-31) for the operation of a Vacation Home Short Term Rental from a single-family dwelling in the R-1 Zone, located at 623 Brighton St (APN: 029-120-028). The applicant requests approval to rent out the 1-bedroom home as a Vacation Rental.

Minor Use Permit (22PLN-32) to request the operation of a second Vacation Home Short-Term Rental from a duplex in the Neighborhood General 2 (NG-2) Zone, located at 352 Marshall St (APN: 029-150-026). The applicant requests approval to rent out a 2-bedroom second level of a duplex as the second Vacation Rental on the property.

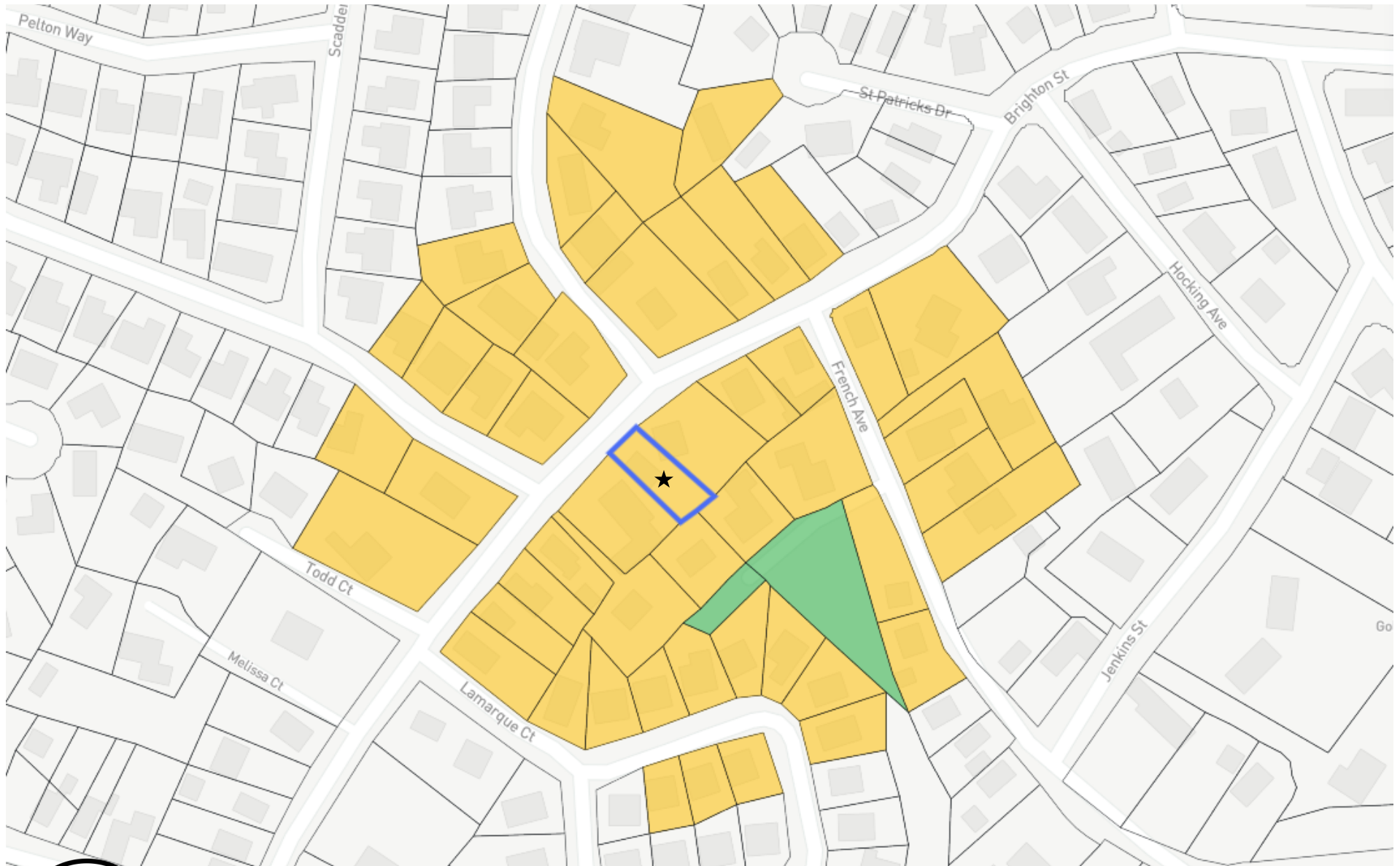
