



Persons Contacted: The Landowner was not familiar with any prehistoric activity; however was aware of the historic era farm house associated with the Berriman Dairy Farm located in the project vicinity.

Summary of Results of Pre-Field Research: According to Wilson and Towne in the Handbook of North American Indians Volume 8 this area was predominately inhabited by the Nisenan culture. Typically in this part of Nevada County, Native American archeological sites are found on broad midslope terraces near intermittent or perennial water. The proposed THP area includes flat, gentle, and steep slopes with close proximity to water. The THP area is at 2,300± feet elevation so any prehistoric activity would likely be seasonal with migrations towards lower elevations during the winter period. Due to these conditions there is a low to moderate likelihood of finding prehistoric-period resources within the project area.

The surrounding area in which the proposed THP takes place is well known for historic mining and logging activity and several historic resources remain within the general location. Due to these conditions there is a low to moderate likelihood of finding historic-period resources within the project area.

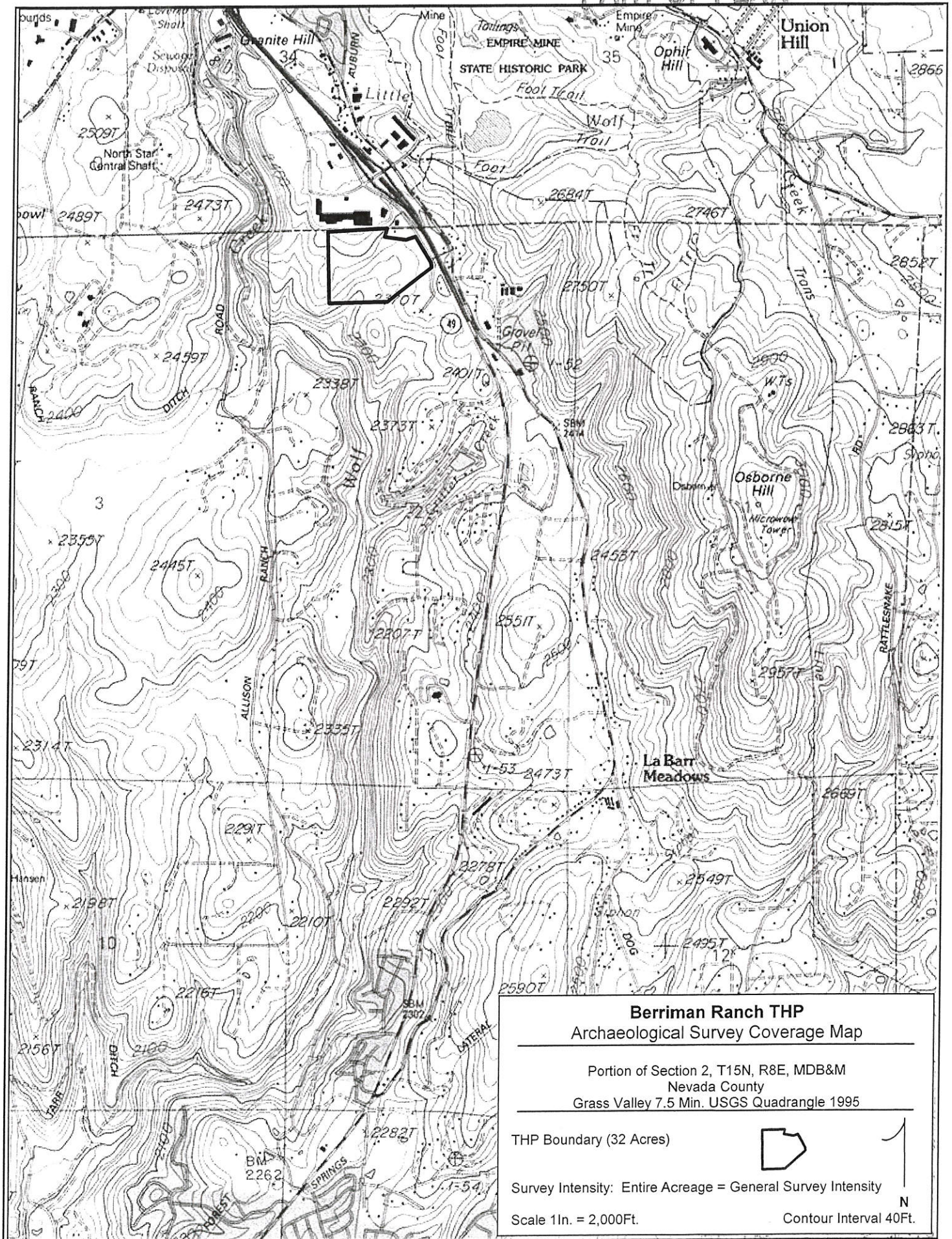

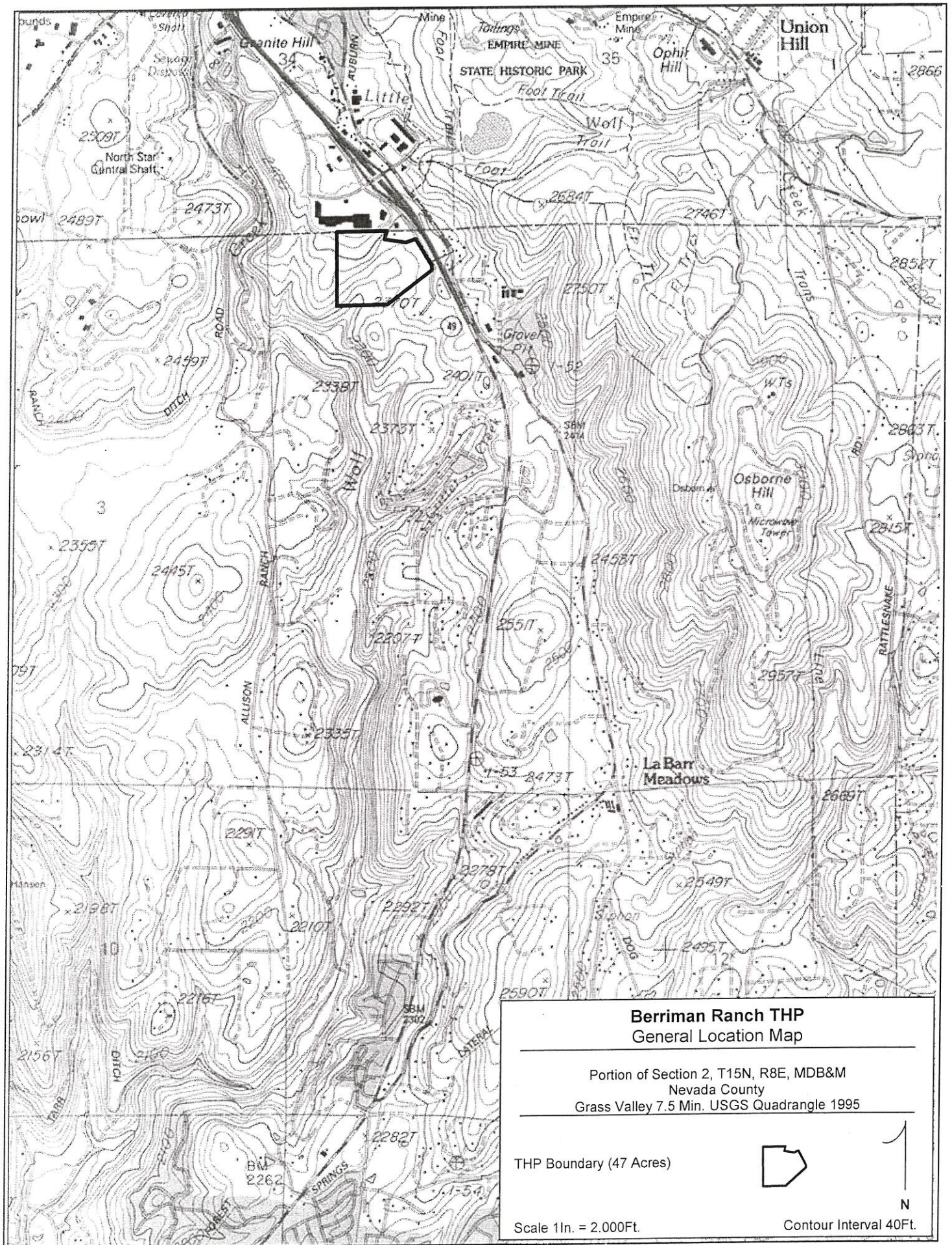

Dear Cultural Resources Representative

David Levy Forestry Services, The "CAN DO" Company, is in the process of preparing a Timber Harvest Plan (THP) in Nevada County. Timber harvesting plans oftentimes include the construction of skid trails, roads, and log landing areas in addition to tree cutting over a period of time that lasts from one to five years. The primary purpose of this written notification, which is required by the Forest Practice Rules, is to provide you with an opportunity to disclose the existence of any Native American archaeological or cultural site that you know or suspect may be located within the project area, and to advise you of the opportunity to comment on the plan.

As part of my archaeological review for this project I respectfully request any information that you wish to share about cultural resources that may exist within the project area. This notification provides you the opportunity to disclose the existence of Native American archaeological or cultural sites that could potentially be affected by the project and the opportunity to submit other comments regarding the project.

The project is located on Taylorsville Road in the community of Grass Valley, California. The legal description is a portion of **Section 2, T15N, R8E, MDB&M**. A map is enclosed to provide the precise location with the travel route from the closest community or landmark on a USGS 7.5' topographic quadrangle. The map displays the approximate boundary of the plan area and includes a map legend and scale.

If you have any information concerning archaeological or cultural sites within the project area, or if you have any questions concerning the proposed THP, please contact me at the address or phone number above. If you respond within 10 days of the postmark date at the address or phone number above, or any other time prior to submittal of the plan to the California Department and Fire Protection (CAL FIRE), site locations and protection measures can be incorporated into the project report. Locations of sites you disclose will be kept confidential. I expect the plan will be submitted to the CAL FIRE Director on **February 6, 2015**. The earliest possible date the Director may approve the plan is 16 calendar days after it is submitted to Director, although typically, the plan is reviewed for at least 45 calendar days following plan submittal before the Director approves the plan.

After the plan has been submitted to CAL FIRE, Native American groups may still participate in the plan review process by submitting written comments to the Director before the close of the public comment period. A Confidential Archaeological Addendum (CAA) will be prepared for the plan and a copy of pertinent information contained within the CAA may, at the discretion of the Director, be obtained from the Director at **CAL FIRE, 6105 Airport Road, Redding, CA 96002 (530) 224-2445**. Please refer to the **Berriman Ranch THP** in any correspondence, and contact me if you have any questions or information that will help identify and protect archaeological and cultural sites.

If a Native American archaeological or cultural site is identified within the project area during the project planning process, you will receive a second written notification from me that includes both site description and protection information. This second notification will describe the proposed measures taken to protect the site during timber operations and provide you with the opportunity to submit comments to CAL FIRE concerning the adequacy of those protection measures.



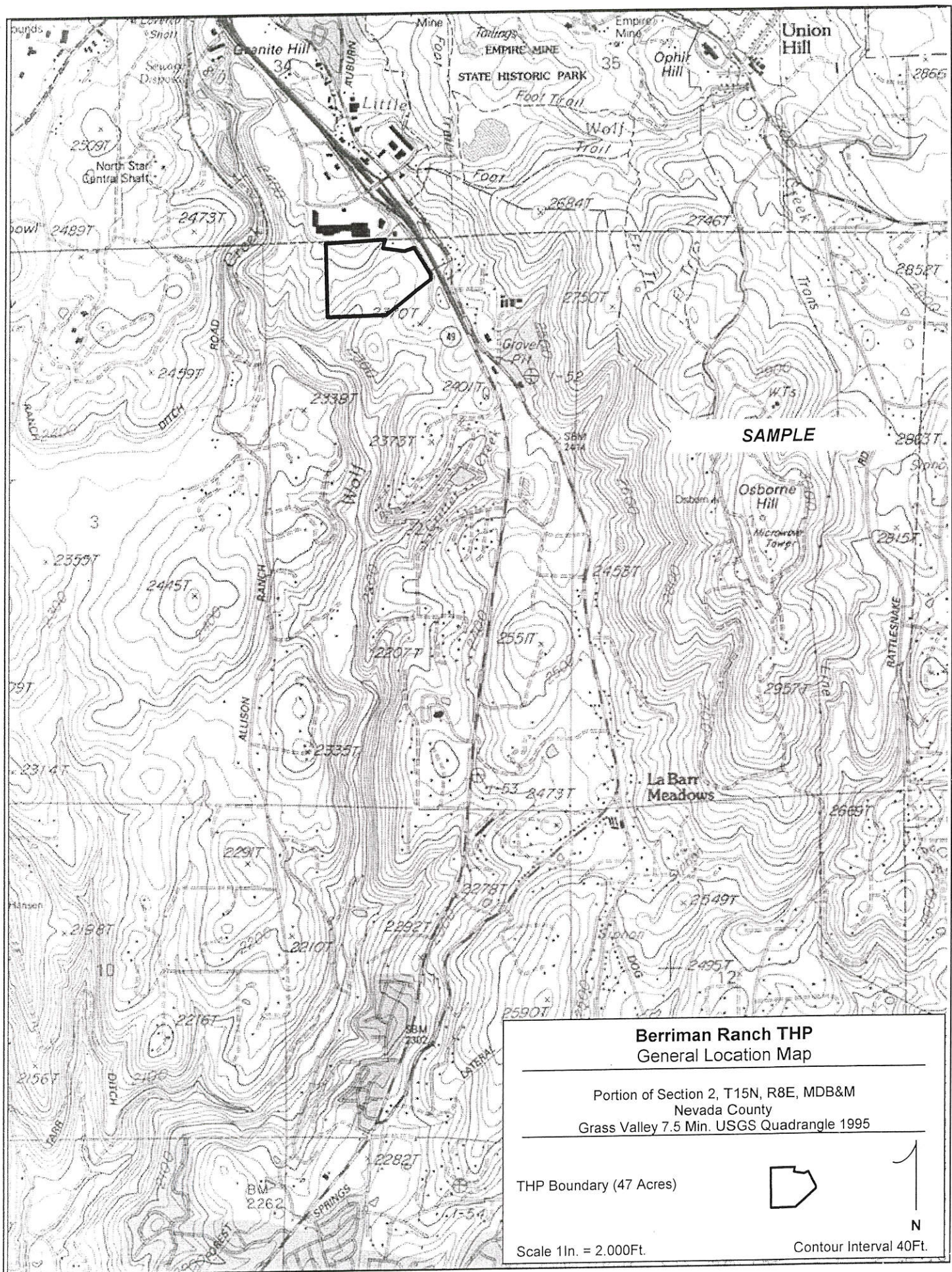

Per your request received by our office on 1/23/2015, a complete records search was conducted by examining California Historic Resources Information System (CHRIS) maps for cultural resource records and survey reports in Nevada County. This review was limited to the project area plus a one-sixteenth-mile search radius.

RESULTS

Previous Archaeological Investigations: It appears approximately 90% of the Berriman Ranch THP search area has been previously surveyed for cultural resources. Survey coverage is shown on the accompanying maps, and bibliographic references are enclosed for the following reports: 2894 and 5565.

Prehistoric-Period Cultural Resources: The Berriman Ranch THP search area contains zero (0) recorded prehistoric-period cultural resources listed within the California Historical Resources Information System (CHRIS).

In this part of Nevada County, archaeologists locate prehistoric-period habitation sites adjacent to streams or on ridges or knolls, especially those with southern exposure (Moratto 1984:290). This region is known as the ethnographic-period territory of the Nisenan, also called the Southern Maidu. The Nisenan maintained permanent settlements along major rivers in the Sacramento Valley and foothills, and periodically traveled to higher elevations to hunt or gather plants (Wilson and Towne 1978:387-389). The Berriman Ranch THP search area is situated in the Sierra Nevada. It encompasses gently sloping terrain with elevations ranging from 2350 to 2400 feet; drainage to Wolf Creek flows northeast to southwest. Given the extent of known cultural resources and the environmental setting, there is moderate potential for prehistoric-period cultural resources in the Berriman Ranch THP project area.

Historic-Period Cultural Resources: The Berriman Ranch THP search area contains one (1) recorded historic-period cultural resources listed within the California Historical Resources Information System (CHRIS).

Within the search area, the 1870 GLO plat of T15N, R8E shows evidence of nineteenth-century mining activity. The 1949 Grass Valley 7.5' USGS topographical map shows evidence of a twentieth-century building. Given the extent of known cultural resources and the patterns of local land use, there is moderate potential for historic-period cultural resources in the Berriman Ranch THP project area.

From this point, proceed southwesterly along driveway to a circular driveway loop and site area. Site is situated on a mid-slope terrace.
- P3a. Description:** This site consists of a small ranch complex containing eight (8) features—a residence, barn, workshop, work shop/garage/storage area, and four (4) small storage or work sheds all similarly constructed and similar in size. Overall, the site extends approximately 320 feet in length (east-west), with a maximum width of 200 feet, covering approximately 60,000 square feet of land surface area. The eight features include the following:
- A. Feature A consists of a two-story, wood-framed and wood-sided residence. The footprint of the structure extends 36' in length (northwest-southeast) by 28' in width. The structure was constructed over a foundation that combines concrete stem walls and cast concrete piers. Wall studs and roof rafters are 2" X 4" milled lumber, while the exterior walls are covered with horizontal, "ship-lapped" 1" X 6" siding. Two simple gable ends are located at the front of the house, one of which is the terminus of the roof line for the primary enclosure, while the second at half the width of the other represents an extended porch overhang of eight feet. Roofing material is split cedar shakes (original covering) over which corrugated steel was subsequently fastened. Windows are a combination of wood sash and fixed (non-opening "Bay") varieties. A small shed-roofed addition is located on the north side which appears to represent an added wash room or utility porch, while a shed-roofed porch cover is located at the rear of the house extending rain protection by four feet.
- B. Feature B consists of a workshop with an added covered carport or equipment storage area adjacent to the original shop structure. The footprint of the structure extends approximately 32' by 32' and was constructed over a foundation that combines low concrete stem walls, local field stones, and cast concrete piers. Wall studs and roof rafters are 2" X 4" milled lumber, while exterior walls are covered

with a combination of vertical 1" X 12" cedar with 3" bats, and corrugated steel which is also the material utilized on the roof. Double swinging "barn doors" provide access to the original shop area, which has a dirt floor.

- C. Feature C consists of what appears originally to have functioned as an equipment shed or work shop with a partial wood floor, but which is currently used a single-vehicle garage. An extensive shed-roofed addition has been added to one side of the structure for equipment and other storage. The original equipment shed or work shop portion of the structure is on the northeast side of the building, while the storage area appears to have been added to the southwestern side, perhaps at a later date. Constructed over cast concrete piers, the equipment shed or work shop portion of the structure is framed with 4" X 4" posts while the shed-roofed storage area utilized 2" X 4" studs. Exterior siding includes a variety of material, including 1" X 6" boards placed vertically, 1" X 6" tongue and grooved material placed horizontally, 1" X 10" boards placed vertically with 3" bats covering the butt joints, plywood, and corrugated metal. The floor of the shop area includes a wood planked floor (underpinning undetermined), while the roof of the entire structure is covered with corrugated steel.
- D. Feature D consists of a livestock barn with an overall footprint of 94' in length (northwest-southeast) by 50' in width. Most of the structure represents post and beam construction erected over cedar beams placed on an un-mortared rock "skirt" foundation, or in some areas with the cedar beams placed directly on the ground. The interior floor is wood planked (underpinning undetermined), while the roof of the entire structure is covered with corrugated steel. As noted, most of the structure presents post and beam construction accomplished with 6" X 6" posts with a variety of additional material (including 2" X 4", 2" X 6", 4" X 4", 4" X 6") forming "X" supports, cross-ties, in-filled wall sections, and roof rafters. Several episodes of construction appear to be represented, with later additions utilizing 2" X 6" milled boards. Siding includes vertical cedar material of full 1" thickness, varying in width from 14" to 8"; no bats were used to seal spaces between the vertical siding boards. Several non-opening windows have been installed within a portion of the upper floor of the barn to illuminate this area. Elsewhere windows are not present. A number of both sliding- and hinged-barn doors are present around the perimeter of the building.
- E. Feature E represents four small sheds varying from 10' X 12' to 10' X 16' but similarly constructed. Building foundation perimeters are 4" X 4" beams laid directly on the ground or on a few local field stones, with the walls and rafters formed from full-cut 2" X 4" milled lumber. Exterior walls are covered with a combination of 1" X 10" cedar boards placed vertically with bats covering the butt

joints between them. Corrugated steel covers the roof and was also used as partial replacement of some of the original wood siding.

According to information provided by the property occupant, Mr. Ed Wright, the residence was originally constructed in 1928. Mr. Wright did not have any knowledge as to the origin of the remainder of the structures, but did indicate that a number of small, contemporary plastic and metal storage structures were placed on the property within the past five years. These latter features were not recorded as part of the present historic site.

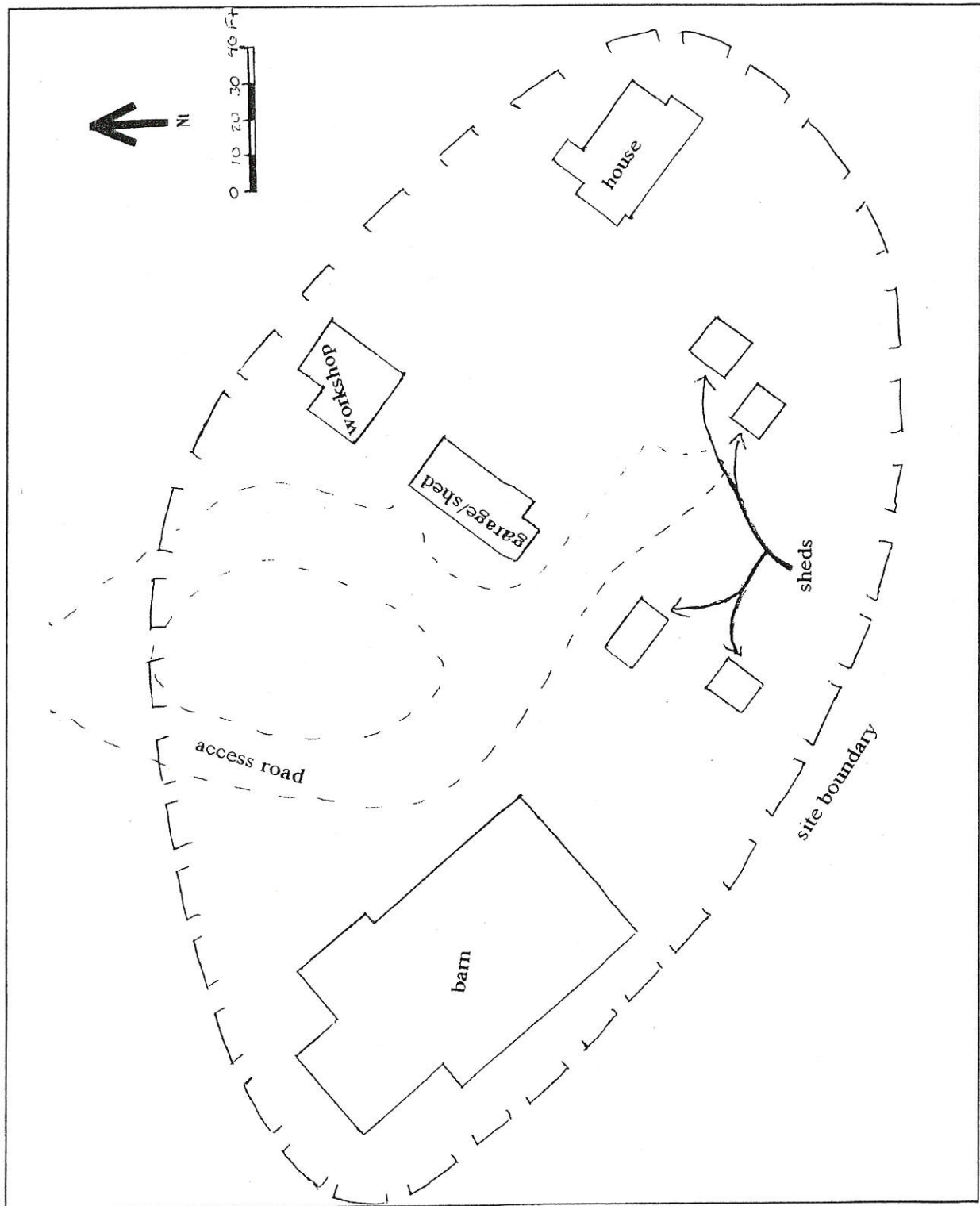

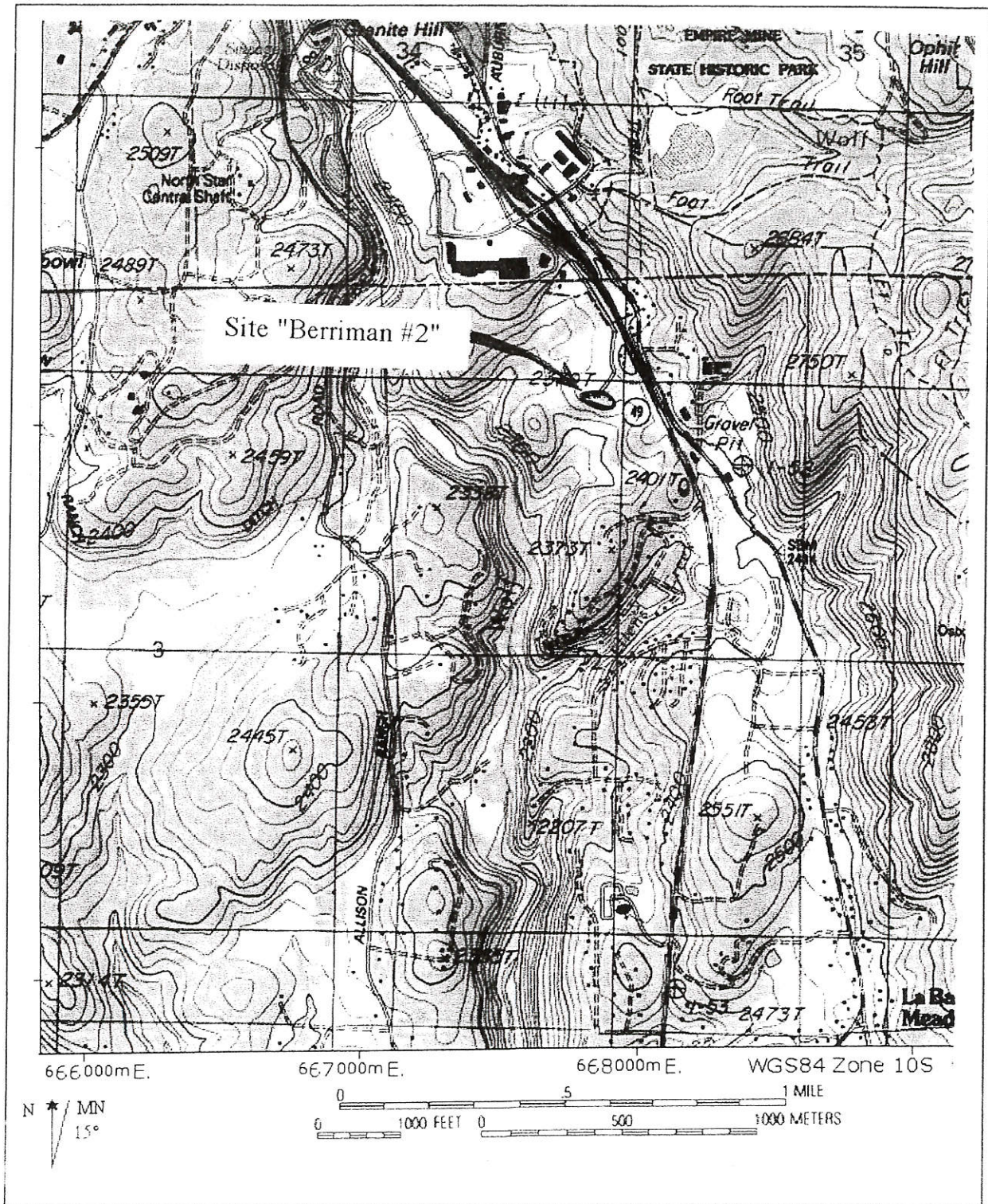

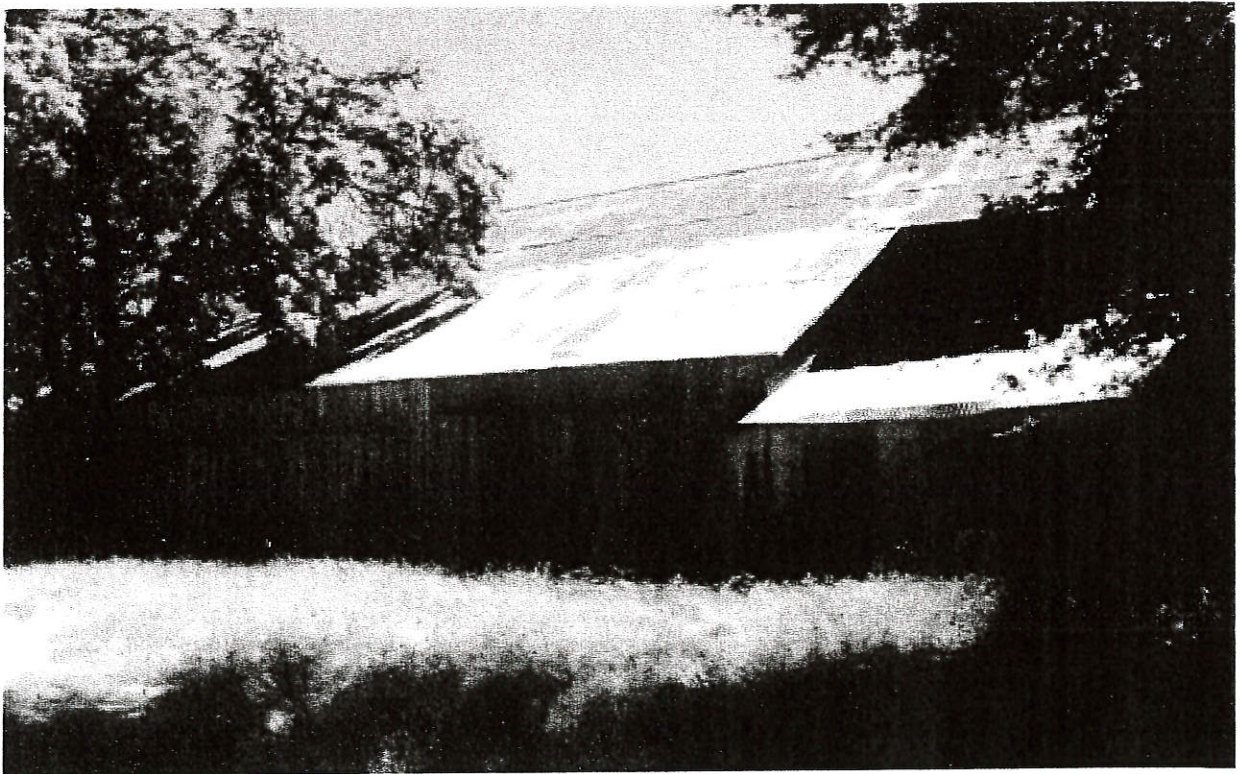

ATTACHMENT: Site Location Map, "Berriman #2"

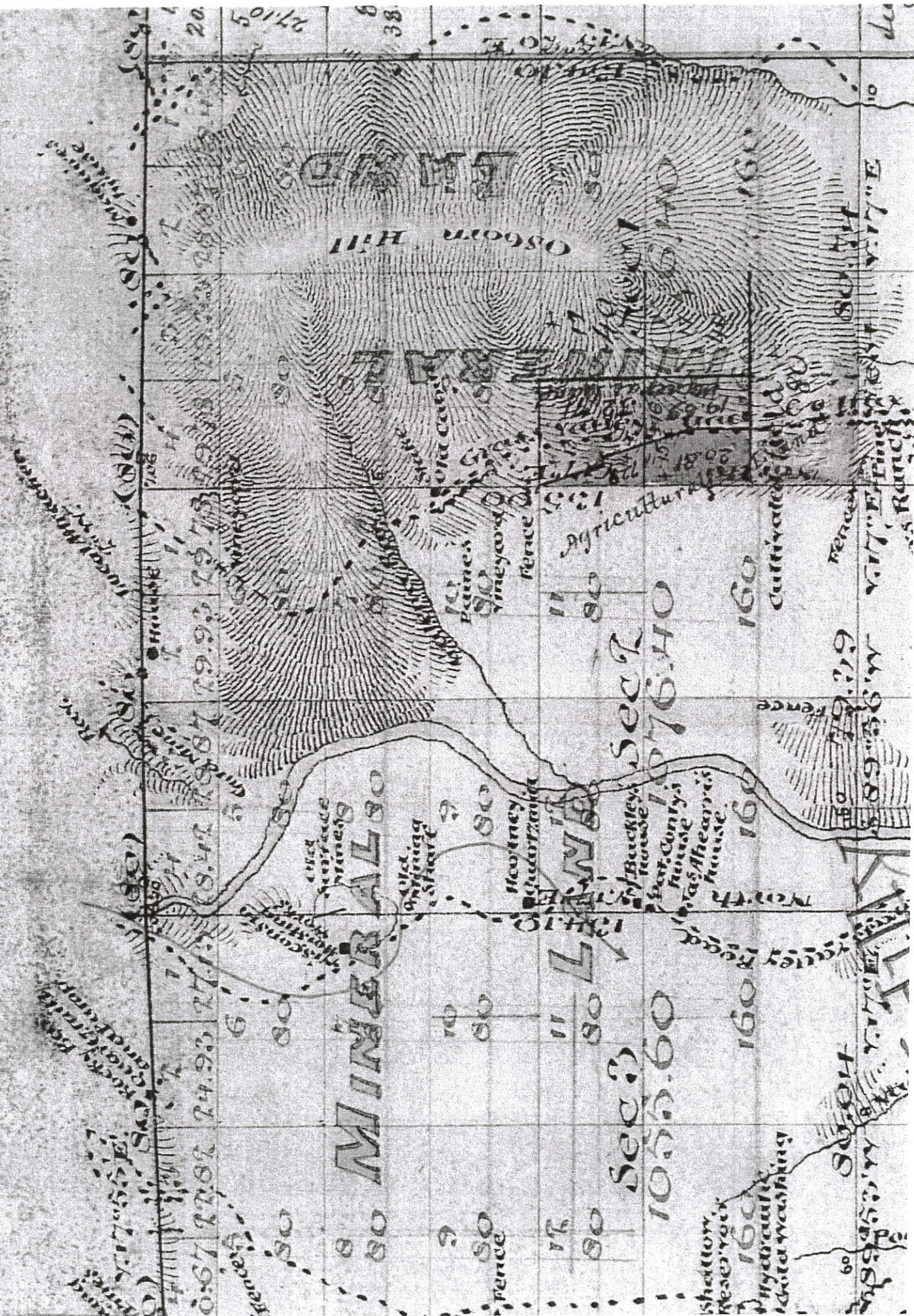


ATTACHMENT P5b: Site "Berriman #2": Residence (Upper); Barn (Lower).
