- 5.1 Development Review and Use Permit (20PLN-22) for the construction of a ±900 square foot Dutch Bros. building with drive-through and related site improvements in the Central Business (C-2) Zone. The project is located at 2094 Nevada City Highway (APN: 035-280-022). Environmental Determination: Categorial Exemptions.

5.2 Conceptual Development Review (20PLN-15) of a storage facility consisting of equipment and shipping containers in the City's Sphere of Influence. The project is in unincorporated Nevada County and the City is providing comments to the County regarding consistency with the City's standards (APNs: 009-680-048, 009-680-051 & 052). No formal action will be taken on the Conceptual Development Review application. Environmental Determination: Nevada County will prepare the appropriate level of environmental review for the project.
