#### **Application Period**

Applications will be accepted at the Nevada County Consolidated Fire District located at 640 Coyote Street Nevada City, CA 95959. The acceptance of applications will begin on Monday, April 9<sup>th</sup>, 2018 at 0800 and end on Monday, April 27<sup>th</sup>, 2018 at 1700 hours. All applications will be time and date stamped upon receipt. Applications received after 1700 on April 27<sup>th</sup>, 2018 will not be considered. Applications may be submitted in person or by mail. Faxed or emailed applications are not accepted. ## Minimum Qualifications:

Valid EMT and CPR certification. Be at least 18 years of age. High school diploma or GED equivalent. No felony convictions. Valid California driver's license with a clean driving history. Satisfactory enrollment in a California State Fire Marshal Firefighter I Accredited Academy with successful completion by appointment date.

- 7. Satisfactory enrollment in or successful completion of a California State Fire Marshal Firefighter I Accredited Academy. Proof of current attendance or passing verification of a California State Fire Marshal FF1 Academy by letter from Academy Director or college transcripts or certification of completion:

- 9. One copy of resume;
- 10. Attach only requested certifications.

### **Selection Process:**

The first 50 qualified applications will be selected for oral interviews and written test (if needed). Tentative Oral Interview Date: Wednesday May 16th, 2018 and Saturday May 19th, 2018. Background Investigation may be conducted upon appointment to position.

#### **Duty Requirements**
