As a condition of being issued a Septic Hauler Permit by the City of Grass Valley, I hereby certify and acknowledge the following:

1. Authorization for Use

I am authorized to operate as a permitted septic hauler in Nevada County and to utilize the City of Grass Valley Wastewater Treatment Plant for the disposal of septic waste in compliance with this permit.

2. Compliance with Regulations

I agree to comply with all applicable federal, state, and local laws, ordinances, and regulations governing the collection, transportation, and disposal of septic waste, including but not limited to the Grass Valley Municipal Code, California State Water Resources Control Board requirements, and any rules established by the City.

3. Proper Disposal Practices

I certify that all waste delivered to the City of Grass Valley Wastewater Facility for disposal has been lawfully collected and is limited to domestic septic tank waste. No hazardous, industrial, or unauthorized waste will be transported to or disposed of at the City's facility.

4. Accuracy of Records

I agree to maintain accurate trip logs and disposal records and to provide such documentation to the City upon request.

5. Assumption of Responsibility

I accept full responsibility for the proper conduct of myself, my employees, and my vehicles while operating at or in connection with the City's Wastewater Treatment Plant.

6. Damage to the Facilities

I shall pay for all damage to City-owned property caused by me, my agents, employees, or invitees.

7. Indemnification

I shall hold harmless, defend and indemnify City of Grass Valley its officers, officials, employees and volunteers from and against all claims, damages, losses and expenses including attorney fees which actually or allegedly arise out of its participation in this program, caused in whole or in part by any negligent act or omission of myself, any subcontractor, anyone directly or indirectly employed by any of them or anyone for whose acts any of them may be liable, except where caused by the active negligence, sole negligence, or willful misconduct of City of Grass Valley its officers, officials, employees and volunteers.

8. Acknowledgment of Permit Conditions

I understand that failure to comply with the conditions of this permit, or falsification of information, may result in suspension or revocation of my permit, denial of facility access, and/or enforcement action as authorized by law.
