If trees are 24" dbh or larger you will receive notification of a *PROPOSED ACTION* by mail indicating your ten (10) calendar day posting period with required poster or requesting additional information if required to process your request.

Following the 10-day posting period there is a seven (7) calendar day appeal period, after which you will receive notification, by mail, of the *FINAL ACTION*. The Final Action will specify if you are allowed to remove the tree(s) and, if so, the conditions by which you are able to remove the tree(s), and any other *CONDITIONS* that may apply (i.e.: replanting).

Removal of trees, subject to the City's Tree Preservation and Protection Municipal Code Sectopm 12.36, without written City authorization may be subject to fines and or criminal prosecution.

*The City of Grass Valley is not responsible for location of trees marked for removal.  
All property lines should be verified before submitting your application.*

Consent Terms (Property Owner to initial each item):

\_\_\_\_\_ *In consideration of removal and as mitigation for the above referenced tree(s), I agree to replant at a 1:1 ratio in accordance with Municipal Code 12.36.085 (reading in part), with either a minimum one and one-half inch caliper diameter, healthy and well-branched deciduous tree, or a five to six foot tall evergreen tree. The replanted tree shall be of a species that will eventually equal or exceed the removed tree in size, if appropriate, for the new location(s).*

\_\_\_\_\_ *The permittee shall be responsible for all claims and liabilities arising out of work performed pursuant to the tree removal permit, or arising out of the permittee's and his/her agent's failure to perform any of the requirements of the permit. The undersigned hereby agrees to indemnify, defend and hold harmless the City of Grass Valley, its officers, agents, employees and volunteers from any and all liabilities, claims, losses and expense, including attorney's fees and court costs and interest, in any manner caused by, of whatsoever kind of nature, arising out of, or in connection with, this Tree Removal Permit, except as caused by the sole or gross negligence of the City.*
